09.30 – 10.45 Session 1 – Enhancing EU-Africa Cooperation on Climate Policy and the Green Economy

Africa's ecosystems are acutely vulnerable to the global impact of climate change, placing long-term trajectories for sustainable development under serious threat. In recognition of these challenges, the March 2020 European Commission communication 'Towards a Comprehensive Strategy with Africa' highlighted green transition and energy access as the first area of partnership for a future EU-Africa strategic alliance. To move towards a green transition in which escalating climate risks are balanced against increasing demands for energy generation and food production, cooperation between Africa and Europe can offer vital opportunities to strengthen innovation capacity, encourage sustainable natural resource management, promote green jobs and generate investment in efficient, low-carbon technologies, but the two regions must also successfully navigate different priorities and approaches to poverty reduction, development and job creation.
